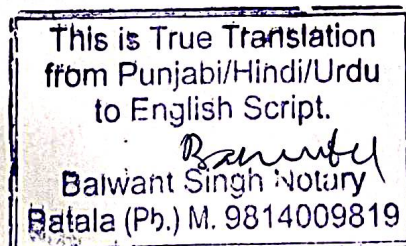
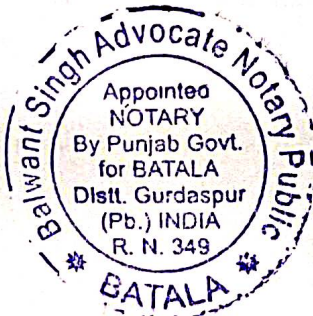

In the above context in reference to your application no. 2DFEAAOBCD,

As per documents and affidavits submitted by the management of the school, recommendations of District Education Officer, Gurdaspur and as recommended by the Director Education(Sec), Punjab, Mohali, no objection certificate has been issued on the following conditions :-

- 1) This no objection certificate can be withdrawn if during the inspection by the department it has been found that the affidavits/statements in along with the application were wrong or the guidelines issued from time to time by the departments have not been complied with.
- 2) Punjabi teaching upto 10th level will be compulsory in the school & CBSE New Delhi will ensure to take Punjabi examination & for non-compliance, this no objection certificate will be cancelled with immediate effect.

- 3) School management will ensure to implement notification issued by the Education department Govt. of Punjab under RTE Act 2009 and rules of RTE Act 2009.
- 4) The management of school is bound to treat teaching and non-teaching staff as Govt. Employees and will disburse salary and other benefits through account payee cheques after getting affiliation from the CBSE New Delhi. The reserve dues of teaching and non-teaching staff will have to be deposited with the concerned Distt. Education Officer as per govt. instruction at the time of school extension/up gradation. Non-compliance will lead to cancellation of no objection certificate.
- 5) You and your management will ensure to submit the information ask by the education department or any of its senior officials and when demanded. Non-compliance will lead to cancellation of no objection certificate.
- 6) The Punjab govt. officials will verify the conditions laid down in the no objection certificate and safety and public health facilities for the children from time to time.
- 7) Strict compliance be done of guidelines issued by the Punjab govt wide letter no: 2/93/2009/3c3/1360154 dated 26.11.2018.

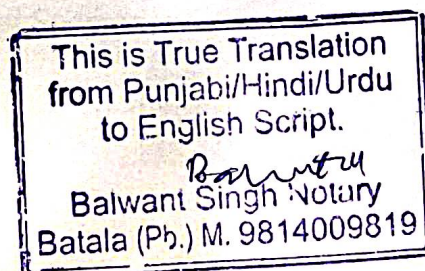
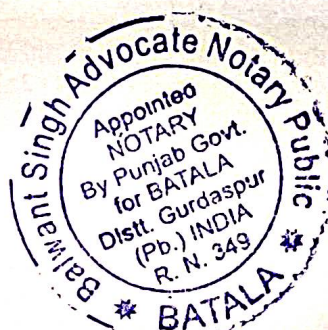

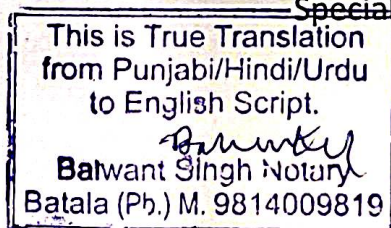
